



# "The Road Back - Restart and Recovery Plan for Education"



The New Jersey Department of Education [NJDOE] released the "The Road Back – Restart and Recovery Plan for Education" (RRP Guidance) for schools to reopen in September 2020. The RRP provides guidance related to four key subject areas:





# **District Restart Committees**

#### Data Collection

#### Parents surveyed with open-ended responses on remote instruction and the proposed A/B and AM/PM schedules.

- Input from HSA leadership was solicited on committee recommendations.
- Focus groups of middle and high school **students** were held to solicit student input and insight.
- SEPAC leadership met with the Director of Special Services to share their thoughts and concerns.
- Information collected from neighboring districts through BCPSA Meetings.

#### Collaborative Planning

- Committees of stakeholders met several times via Zoom to create plans that complied with NJDOE guidelines, considering all aforementioned data.
- Committee chairs met weekly to discuss logistics and compare plans.
- Adjustments and revisions were continual as guidance became available and as decisions in other committees had overlapping implications.
- 4. **Meetings with GREA Leadership** were held to discuss areas of concern.

# The Three Phase Model

#### **Red Phase**

In the case of **high risk**, complete school closure may be necessary. Students learn virtually from their homes in this phase.

Students receive instruction remotely through a combination of synchronous and asynchronous lessons and activities

#### **Yellow Phase**

In the case of **moderate risk**, schools will operate on a modified / hybrid schedule with reduced student attendance.

Social distancing and proper hygiene protocols are in place to prevent spread and mitigate risk

Students with receive a minimum of 4 hours of instruction through a hybrid model that combines in-person and online synchronous and asynchronous lessons and activities

#### **Green Phase**

In the case of **low risk**, schools will operate on typical / normal schedule.

Schools are open at full capacity and all students are in the buildings

Staff and students will continue to focus on best practices to reduce spread of COVID19

# Red Phase

# Elementary Level (K-5)

- The four (4) elementary buildings would operate on a half day (4-hour) schedule from 8:30 am and 12:30 pm.
- During these hours, students would participate in a variety of instructional activities including, but not limited to: live instruction, extension activities, independent practice, small group meetings, etc.
- From the hours of 12:30 pm 3:30 pm, teachers will be available to answer questions, give individualized help, etc.

- Monday, Tuesday, Thursday & Friday: Students will follow their bell schedule as shown above and attend full days of classes. Activities will include both synchronous and asynchronous activities, including live instruction.
- **Wednesday**: Mid-week, students will participate in an "Academic Support" day, which will include independent learning activities, small group meetings, opportunities for wellness, and extensive teacher support sessions.

# Yellow Phase

Elementary Level (K-5)

### **AM / PM Shift Model**

#### "AM/PM Shift" Model Logistics

- Half of the students in each grade level will be designated "AM students" and half will be designated "PM students." Students will remain in their designated shift/group, to establish consistency for student routine as well as parents/child-care schedules.
- Siblings / same household children will be placed in the same group.
- Shift preference considered through parent survey. However, grouping will be driven by programming, ELL, G&T, Resource Room, Basic Skills and related services.




 Due to the minimal time spent in the school building daily, students will not eat lunch in the building.

#### Daily Instruction for an "AM" Student


#### Daily Instruction for a "PM" Student

- The four (4) elementary schools will utilize "AM" and "PM" assignments to reduce student attendance by 50%.
- In-person instruction will be prioritized to include the most critical skills and knowledge in each content area;
   students will receive "specials" (art, physical education, music, world language, etc.) through live instruction during the shift they're learning from home via Zoom or a similar platform.

Middle & High School Level (6-12)



Instruction for an "A" Student on an "A" Day

- During in-person school days, students will move throughout the school building and attend their classes.
- During the virtual day, students may be (not a comprehensive list): reading, completing extension activities or homework, participating in "live" instruction, or asynchronous activities. Virtual instruction activities will accumulate to no less than four (4) hours of engagement, the mandatory minimum set forth by NJDOE.

# Yellow Phase

Middle & High School Level (6-12)

#### "A/B Rotational" Model - Logistics

- Half of the students in each grade level will be designated "A-Day students" and half will be designated "B-Day students." Students will remain in their designated group.
- Siblings / same household children will be placed in the same group.

#### **Student Lunch**

- Student lunch will take place in the cafeteria. Three students can sit safely without a mask at each of our cafeteria tables (all facing one direction).
- The Courtyard and Gym spaces will still be available for students who are NOT eating if they'd like to **socialize**, do school work, etc.
- Lunch "privilege" will be extended to 11th grade students during the Yellow Phase to alleviate capacity concerns.



# **Virtual Instruction & Assessment Considerations**

#### **Formative Assessment:**

- Beginning-of-Year assessments will determine content and learning gaps
- Ongoing, quick formative assessments will be used to determine student progress both virtually and in-person

#### **Summative Assessment:**

- Summative assessments may be delivered virtually through Schoology for 6-12
- Benchmark assessments will be adjusted based on formative assessment data

#### **Virtual Instruction:**

- Small group/1:1 meetings with teacher
- Asynchronous learning
- Participating in class through **Schoology Discussions**
- Live streaming of classroom instruction
- Project-based learning options
- Extension activities of content taught in-person
- Reading, writing, and reflecting





# **Green Phase**

### All Levels (K-12)

#### **Elementary Level K-5**


• The four (4) elementary buildings would resume typical operation

#### Middle & High School Level 6-12

- Glen Rock Middle School: GRMS would resume a typical bell schedule.
- **Glen Rock High School:** GRHS would resume a typical bell schedule, including the resumption of "dropped" periods and the shift back to "normal" bell schedule.
- **Glen Rock High School:** Having started the year with lunch "privilege", grade 11 students will continue to have this option for the remainder of the school year.
- Glen Rock High School: Students who exercised the ability to come in late / leave early for "option" (study hall) period will resume attending school regularly at this time, aside from grade 12 students with signed senior privilege forms.

Ongoing assessment, including feedback from all stakeholders, will shape future offerings for teachers.



# Special Services and Delivery of Services

#### **Remote/Hybrid Considerations**

- → Providing ongoing implementation of students' Individual Education Plans/504 plans during both virtual and hybrid instruction to the greatest extent possible.
- → Case managers, teachers, and related service providers will remain in contact with parents as required via phone, email, Zoom and/or other virtual platforms.
- Accommodations and modifications identified in students' IEPs will continue to be adhered to in the virtual and hybrid learning environments.

#### **Related Services**

- Related services from school psychologists, social workers, occupational, speech/language, and physical therapists.
- → Sage Day counselors and services will also be provided to both students and their families who utilize their services.
- → Students will be provided with access to their teacher assistants via a range of appropriate platforms throughout the instructional day.

# Before & After Care Program Modifications

#### Time

AM Students will be able to attend **Before** Care,

7:00 AM - 8:25 AM.

PM Students will be able to attend **After** Care,

3:18 PM - 6:30 PM.

#### **Outdoor Use**

**As much outdoor time** as possible will be incorporated into the program.

# **Contact Considerations**

Students will be **grouped with their grade** when possible and always be with the same group of before and/or after care students.

**Contactless** drop-off and pick-up.

#### **Supplies**

Families will be sent a **supply list** to be stored at the program, such as markers, crayons, etc.

# Health & Safety Considerations



All staff, students and building visitors will be **required** to wear a facial mask with a 3-ply minimum standard. District staff will be provided with **3-ply facial masks**, **face shields** and **portable Plexiglass** dividers..

2 Self-Check and Contact Tracing

Parents/guardians and staff will be required to **fill out a form daily** (via Genesis or district purchased app) confirming that his/her child has not come into contact with anyone who has tested positive for, or experienced symptoms of COVID19.

3 Temperature Checks

All staff and visitors shall be required to complete a temperature check via a **Temperature Check Kiosk** located at each building. Each day, twenty percent of the students will be randomly selected and have their temperature checked via each school Temperature Check Kiosk.

4 Cleaning/Disinfecting Procedures

A detailed district COVID-19 cleaning and disinfecting procedural manual is currently being prepared per each school's respective instructional schedule. District will **increase** daytime **custodial staffing**. **Touchless hand sanitizing stations** will be installed in all common areas and classrooms.
